Keyword	Definition	Use of keyword within context
Parliament	an assembly of the representatives of a political nation or people, often the supreme legislative authority	In the UK, governments are accountable to Parliament
Judiciary	the branch of the central authority in a state concerned with the administration of justice	An independent judiciary is one of the cornerstones of the UK constitution
Statutory	relating to rules or laws which have been formally written down in a statute	Unions want a statutory right to time off for training.
Delegate	to give or commit (duties, powers, etc) to another as agent or representative	If you're too busy, learn to delegate
Scrutiny	close or minute examination	The figures are likely to come under close scrutiny.
